

Conquering Satan's world just as Jesus did. How can we do that? Part 3

CSB (John 16:33) 33 I have told you these things so that in Me you may have peace. You will have suffering in this world. Be courageous! I have conquered the (Satan's) world."

In the previous article we discussed Judaism with its traditions. The traditions in the Mishnah and the Talmud and already long, the Jews aren't God's people anymore. The different Jewish movements, Kabbalah and the Zohar and the laws of Noah. And about Judaism as a theocracy with the expectation of their Messiah:

NKJV (John 15: 20-21) 20 Remember the word that I said to you, 'A servant is not greater than his master.' If they persecuted Me, they will also persecute you. If they kept My word, they will keep yours also. 21 But all these things they will do to you for My name's sake, because they do not know Him who sent Me.

NKJV (Matthew 10:17) 17 But beware of men, for they will deliver you up to councils and scourge you in their synagogues.

Theme; Frank-ism and Jews spread throughout the world as businessmen and owners of (central) banks, the road to chaos.

Frank-ism

Sabbatai Zevi (1626-1676)

In 1665, a Sephardic Jew named Sabbatai Zevi proclaimed himself as the incarnation of the Messiah in the synagogue of Smyrna (Turkey). Zevi suffered from a severe bipolar disorder, with manic periods of exuberance and being excited and periods of depression. The Sabbateans were the followers of the rabbi Sabbatai Zevi, who was confirmed in his vision as the incarnation of the Messiah by the self-proclaimed prophet Nathan of Gaza.

According to the Sabbateans, it is written in the Talmud that through human effort the day of salvation by the actual Messiah can be brought closer.

According to them, this could mean that everyone should be good or that everyone should be bad. By the Talmud, however, everyone cannot possibly be good.

They therefore chose that everyone should be evil by doing as many sins as possible.

The Sabbateans therefore occasionally blessed each other with the twisted verse: 'Blessed are You, Lord our God, who makes forbidden things permissible.'

Conversion to Islam

In 1666, the Turkish sultan gave Sabbatai Zevi the choice: 'Convert to Islam or die.'

Within the Ottoman Empire, the followers of Zevi, who had converted to Islam but who secretly continued Jewish celebrations, were known as the Dönme (converts).

Zevi does indeed seem to have succeeded in convincing numerous Sufi Muslims of his Kabbalistic beliefs, and also to convert many Jews to mystical Islam. A Jewish Islam sect emerged in Turkey, who believed in Zevi as the pseudo-Messiah.

A majority of rabbis in Poland and the Czech Republic (Bohemia and Moravia) supported the Prague rabbis, who excommunicated the Sabbateese cult.

In Ukraine, at that time belonging to Poland, there were still numerous secret societies of Sabbateans, even after the death of Sabbatai Zevi. These were known as the 'Sabbatai

Zeviists'. The members of these societies rejected the ordinances of the strict Jewish dogmas and rejected many religious laws and customs. The leader Jacob Frank came from this group.

Frank-ism

Jacob Frank was born in 1726 in the Polish region of Podolia (now Western Ukraine) out of a rich family. At the age of 12 he went on a business trip to Turkey with his father.

There he came into contact with the centers of Sabbateanism in Salonica-Turkey (now Thessaloniki - Greece) and Smyrna (now Izmir - Turkey). Later on Jacob Frank also came to Turkey as a traveling trader in clothing and precious stones. Sexual debauchery reigned in the cult under the guise of mystical symbolism.

They also advocated nihilism, which rejects the existence of moral values.

The Jewish Muslim sect to which they belonged only acknowledged the Zohar.

It is this book, the Zohar, on which almost all current occultism is based.

In about 1751 he proclaimed himself the direct successor of Zevi and also as the incarnation of the Messiah. Four years later, he formed a sect in Poland - with supporters of the Sabbateans - , who decided that the followers were exempt from the Jewish Torah. The sect left rabbinic Judaism and relied entirely on the Zohar. For that reason, the members also called themselves Zoharists.

Their practices, their orgies, doctrines, and sexual malicious habits led the Jewish community to ban them (the Frankists) as heretics in 1756.

In 1759, the conversion of the Frankists to Catholicism was conducted with the leadership of the Polish Catholic Church.

The final result was that many of the followers accepted Catholic baptism.

Frank inspired his followers by stating that salvation could only be achieved through a strange mixture of Christian and Sabbatean beliefs. Frank's cult was notorious for sexual promiscuity and was accused of adultery and orgies. He was arrested in Warsaw in 1760 and taken to the Catholic Church Tribunal for accusation of false conversion to Catholicism and spreading a harmful heresy and was imprisoned for 13 years.

The transition from the Frankists to Catholicism caused a wave of disappointment among the Jews in Eastern Europe, many of whom had sympathized with the Sabbatean movement in its earlier days. It seems that all his followers in the Czech Republic, Hungary and Romania remained Jews and led a double life for the outside world. For the outside world Jews, but secretly Frankists.

Hasidic Jews

Rabbinic Judaism is not Tenach (Old Testament) Judaism, but Talmud Judaism. When studying the works of Prof. Gershom Scholem, a Jewish expert and well-known historian of Jewish mysticism, we see that Hasidic Judaism did not arise by chance, but had a strong spiritual influence from the Sabbateans.

A new version of Jewish mysticism arose with the Sabbateans. Hasidic Judaism that consists of dozens of ultra-orthodox Hasidic movements such as Chabad- Lubavitch. They are the Ashkenazim Jews from Eastern Europe, Jews who did not become Jews as descents of Abraham as Hebrews but by accepting the Jewish Talmud.

The unconditional belief of Hasidic Jews in their 'just' rebbe (a rebbe is the leader of a Hasidic movement, usually a rabbi) was a consequence of the relationship between Sabbatai Zevi and his followers according to historian Prof. Haim Hillel Ben-Sasson.

According to Gershom Scholem, the trauma caused by the apostasy of the false messiah was one of the factors that explains the beginnings of modern Jewish history.

Warsaw

The Jewish families, who as Frankists followed Frank's example and converted to Christianity, had already started to play an important role in Polish society. Especially in Warsaw, where the vast majority of Frankists settled. Many Frankist families became successful business people and factory owners. Many were also members of the progressive Polish Masonic organizations. According to Gershom Scholem, the vast majority of lawyers in the 1830s in Warsaw came from Frankist families.

His movement, Frankism, spread to Venice, Amsterdam, Hamburg, London and various other European and North African cities. A whole group of Frankist families from Bohemia and Moravia (Czech Republic) emigrated to the US in 1848–1849. For a long time the Frankists kept secret contacts with the Dönme in Salonika. With their emigration, their pernicious ideas were also taken along.

Freemasonry

The port city of Livorno in western Italy was an important center of freemasonry. Of the 34 Masonic lodges that were active in Italy between 1815 and 1860, 19 were in Livorno. The presence of fled Jews from Spain to Livorno dates from the 16th century, when there were already Jewish bankers present in the duchy of Tuscany. Sir Moses Montefiore (1784-1885)

Montefiore, a Sephardic Jew, was born in Livorno, Italy. He was an active Freemason who was initiated into the Moira Freemason Lodge in 1812. His brother-in-law, Nathan Mayer Rothschild, was initiated into the Emulation Masonic Lodge ten years earlier. Montefiore and Rothschild were married to sisters, daughters of Levi Barent Cohen.

Nathan Mayer Rothschild (1777 - 1836)

Nathan's grandfather, Amschel Moses Rothschild (1710 - 1755), was a Jewish money changer and silk cloth trader in the Judengasse, the Jewish ghetto of Frankfurt in Germany. Nathan's father, Mayer Amschel Rothschild (1744 - 1812), was a banker in Frankfurt and sent his five sons for banking to: Frankfurt (am Main), Vienna, London, Naples and Paris. Nathan was the third son of Mayer Amschel Rothschild. Of the five brothers, he was the richest among the Rothschilds. He earned a fortune with banking in London.

As the example of Livorno indicates, many Jews infiltrated into secret societies such as freemasonry. Freemasons serve their own interests and deal with secret and obscure matters that cannot bear the light of day. The wealthy people of this world want to control humanity and keep them under control with their secret agreements:

NKJV (Ephesians 5: 11-13) 11 And have no fellowship with the unfruitful works of darkness, but rather expose them. 12 For it is shameful even to speak of those things which are done by them in secret. 13 But all things that are exposed are made manifest by the light, for whatever makes manifest is light.

Billionaires, Russian oligarchs, Ukrainian ambassadors, international financiers, the Rothschilds and all kinds of glitter people gathered at the 2019 gala for the World Jewish Congress. The meeting represented unparalleled power and wealth.

One of the most important issues of the WJC is the support of Israel. Among the many activities in this area is working with the Israeli government to defend Israel against criticism of its human rights violations and discriminatory system.

The structure of the central banking system

One of the first central banks was De Amsterdamse Wisselbank, established in 1609.

The current central banks may have national names, but the money flows are managed by very rich private wealthy families.

Already for a long time, the knowledge is familiar by banks that if several people deposit their money with a bank they never collect their money at the same time.

Example: If 10 people together save 1000 euros, a multiple can easily be lent on which interest must be paid.

It is customary for central banks to issue fiat money without underlying value.

The central bank cartel is in control of our credit without participation. Something that contradicts with national interests.

The credit system and the insoluble debts

The power of the central banks is based on their monopoly on credit and demands from the taxpayer that they pay billions in interest to them.

Central banks such as the Fed or those with a national name pretend to be government institutions of a country. They may be nationalized, but private organizations decide the policy.

The central bank cartel is the ultimate monopoly. The purpose of private organizations is to translate this into a monopoly on everything - political, cultural, economic and spiritual. According to researchers, the credit claim of only the Rothschild family covers 'half the wealth of the world'.

They want to possess the wealth of all countries, including all private property.

In such a way that when the time of their Messiah (the Antichrist) comes, the Jews will have the ownership of all the peoples of the world under their control. (See: Isaiah 61: 5-6)

Unfortunately, the Scripture in Isaiah is written for the new earth, not for them. Central banks are therefore (in the background) led by Satan's children, people without natural love and mercy:

NKJV (Romans 1:31) 31 undiscerning, untrustworthy, unloving, unforgiving, unmerciful;

NKJV (Luke 16:11) 11 Therefore if you have not been faithful in the unrighteous mammon, who will commit to your trust the true riches?

When the former colony of England, the US, as an extension of the 'West' began to become more productive, the founders of private central banks saw their opportunity in the US.



The architect of the FED was in reality the Rothschild intermediary Jacob Schiff.

A statement about the FED from the former chairman, Mr. Greenspan: "The FED is an independent agency, there is no government that can take overrule actions that we take."

Central banks have enforced autonomous status.

Who opposes them as a king, gets it hard:

NKJV (Daniel 7: 8) 8 before whom three of the first horns were plucked out by the roots.

Three kings or presidents who opposed a private central bank were killed because they were against the exorbitant profit of the private bankers:

16th President Abraham Lincoln - Greenbacks 1865 - murdered

20th President James Garfield - Banking Statement 1881 - murdered

35th President JF Kennedy - execution order 1110 1963 - murdered

Alexander Zinoviev; the end of democracy

The reissue of a 1999 French Figaro interview with Russian human rights activist and scientist Alexander Zinoviev (1922-2006) with the title: 'The end of communism meant the end of democracy in the West.'

Zinoviev is, together with Solzhenitsyn and Sakharov, considered as one of the three most important Russian thinkers and human rights activists in the 20th century.

As early as 1999, Zinoviev noted that he witnessed the 'unprecedented spread of the cult of violence, sex and money' as a means of destroying cultures, communities, religions and families through a toxic synthesis of 'totalitarian financial control' and 'all-powerful military power.' He calls it totalitarian democracy, sham democracy combined with financial dictatorship.

The transformation of the world into one integrated whole, as a brotherhood.

According to him, the goal is a world government (the New World Order). This New World Order is inextricably linked to the monopoly of the Central Banks, which is supported by a military world power.

The text in Daniel 2:42 (And the toes of the feet, partly of iron and partly of clay - that kingdom will be partly strong and partly fragile) is about the rise of the ten-toe empire in the last days. (See also: <https://www.dojc.nl/?p=5113&lang=en>)

Just as the American world power is a greedy and loveless power, so will the empire of the 10 toes of iron and clay be a greedy and loveless empire that is ruthlessly.

The empire has an economic hold on the world and is not interested in the national population. The central banks are linked to the BIS-Bank, the secret bank in Basel, which - so to speak - controls the global money world.

According to our research in Revelation, the empire consists of the 8th world power, the empire that was and is not, a financial empire, with the 10 uncrowned kings of the central banks:

NKJV (Revelation 17: 7-8,11-12) 7....I will tell you the mystery of the woman and of the beast (money-economy) that carries her, which has the seven heads and the ten horns.8 The beast that you saw was, and is not, and will ascend out of the bottomless pit and go to perdition.... 11 And the beast that was, and is not, is himself also the eighth, and is of the seven, and is going to perdition. 12 The ten horns which you saw are ten kings who have received no kingdom as yet, but they receive authority for one hour as kings with the beast.

In 2008, the greedy system almost fell apart. With enormous sums, the banks were saved . The empire of central bank is also fragile, because buying up debts cannot continue indefinitely, or translated, cannot continue to make the rich even richer. NKJV (Matthew 6:24) 24 "No one can serve two masters; for either he will hate the one and love the other, or else he will be loyal to the one and despise the other. You cannot serve God and mammon.

NKJV (Matthew 19:24) 24 And again I say to you, it is easier for a camel to go through the eye of a needle than for a rich man to enter the kingdom of God."

‘Mammon’ means money or wealth.

‘Being greedy or having love of money’ is equated with idolatry in Scripture:

NKJV (Colossians 3: 5) 5 Therefore put to death your members which are on the earth: fornication, uncleanness, passion, evil desire, and covetousness, which is idolatry.

The petrodollar

How central banks are likely to restructure their currencies:

"The central banks are considering a process of mutual payments with crypto-currency, and a process of national currencies that are linked with a currency rate." (Mark Carney, Governor of Bank of England, during his Jackson Hole speech 23 August 2019)

This means that the dollar as a world reserve currency, the petrodollar, will then become no longer valid. Thereafter, the US government will come in serious trouble with its government bonds.

New World Order
